Proceedings of 6th SAC meeting held on 14th September 2012

The 6th SAC meeting of Krishi Vigyan Kendra, Phek was held on 14th September 2012 at the conference hall of the State Tourism Guest House, Pfutsero. The meeting started at 10.00 am with welcome address by Dr. R. K Singh, Programme Coordinator, KVK, Phek. He also briefed about the KVK mandates and activities. Dr. C. Rajkhowa, Director, NRCM, Jharnapani welcomed the members and briefed about the importance of SAC meeting. He emphasized the importance of mithun rearing amongst farming community, mushroom production, jalkund, rabbitry and piggery. He also briefed about OFT, FLD and training programmes. At 11.0AM progress report presentation was done by Dr. R.K Singh, Programme Coordinator, KVK, Phek, The house advised the state veterinary dept to develop 30-35 gramapriya villages in the district, more collaboration needed between KVK and veterinary dept. and requested for developing IFS model. At 12.00 pm Mr. Neiba Kronu, Parlimentary Secretary, address the house. He suggested that there is a need for proper breed selection in different livestock being reared in the region, QPM cultivation for higher production and training on improved technology on large cardamom. At 12.30 pm Mr. Rinku Bharali delivered a presentation of prospects of Kiwi fruit cultivation followed action plan presentation at 12.45 pm. Finally vote of thanks was proposed by Dr. C. Rajkhowa, Director, NRCM, Jharnapani and urged different line departments to work collaboratively for development of the farming community.

Following recommendations were made during the meeting:

- 1. To determine the nutrient content kholar beans varieties.
- 2. To conduct trials on root crops and French bean varieties
- Collaboration needed between KVK and veterinary dept. and requested for developing IFS model.
- 4. To determined the level of GI parasites upto which no clinical signs are exhibited.
- 5. To develop an anthelmatic calendar for the whole year.
- 6. To assist PD, ATMA in seed production programme in farmers field.
- 7. To carry out breed selection in animal science.
- 8. QPM cultivation for higher production.
- 9. Training on improved cultivation technology on large cardamom.
- Suggested to take Moitree var. in Phek district along with trial on different dates of sowing.
- 11. Comparison of SRI with conventional practice.
- 12. To evaluate performance of poultry under QPM feeding, to evaluate nutritive values of local feeds i.e white and yellow maize for poultry,

- 13. To make a health calendar for ruminants,
- 14. To take up vaccination of poultry against pox disease, effect of different vaccines on control of pox disease.
